How the Fund Works

The Taranaki Golf Fund is managed by the Taranaki Foundation. Donations are invested permanently, preserving the capital indefinitely.

Your donation or bequest to the Taranaki Golf Fund will help provide, develop & sustain the game of Golf for all Taranaki. Funds may be used for association operations, sustaining and growing the game, or to benefit a particular club in the region.

Any donation you make will be invested, protected and grown each year. The surplus investment returns will be granted back to the Taranaki Golf Association every year (or named club), meaning your donation will keep supporting them forever.
