TARANAKI GOLF ASSOCIATION EVENTS RULES

TARANAKI 36 HOLE STROKEPLAY CHAMPIONSHIP

The host club to be appointed by the Taranaki Golf Women's Events after applications are called. Open to all members of affiliated clubs. Silver Division 36 Holes Stroke play. Bronze Division 18 Holes Stroke play. Gross winner in each division to receive the Tray and a trophy. Trophy list, Gross and Nett according to entries received. In the event of a tie in the Silver Division or the Bronze Division there shall be a "sudden death" playoff on such holes as the TG Women's Events decide.

TARANAKI TEAMS TOURNAMENT (in conjunction with over 50's below)

This is played at *Inglewood* each year (due to trophy rules) in conjunction with over 50's fixture.

The Stableford total of the best three cards are used for scoring. In the event of a Countback being required, the score of the 4th team member is used.

TARANAKI ANNUAL OVER 50'S TOURNAMENT (in conjunction with Teams above)

Open to all members of affiliated clubs, who are not less than 50 years of age. Silver, Bronze 1, and Bronze 2 divisions, net and Stableford prizes according to entries received.

NEW ZEALAND NATIONAL TEAMS EVENT DISTRICT FINAL

Conditions of play issued annually from Golf NZ and sent to Taranaki Clubs by the TWG Secretary. The date and venue for the Taranaki Final to be printed on the program. Only one team per club is eligible to enter. The final shall be played between 20th April and the 31st May each year.

TARANAKI 27 HOLE FOURSOMES 18 & 9 Hole Divisions

Open to all members of affiliated clubs, limited to 64 pairs. No pair may win more than one trophy and to be eligible for a trophy players must complete the tournament. In the event of a tie for the gross winner there will be a "sudden death" play off over such holes as decided by the TG Women's Events. Nett prizes will be decided on a count back. The venue will be set after applications have been called alternating between North and South Taranaki.

18 Hole teams will complete 27 holes - 9 Hole teams will complete 18 holes.

TARANAKI CHAMPION OF CHAMPIONS AND GROSS STABLEFORD ROSEBOWL

CHAMPION OF CHAMPIONS

The onus is on each individual club to have a local rule determining whether their Match play or Stroke play Champion will represent their club. In the event of that player being unable to attend, she may be replaced by the other champion. Each club shall be represented by one champion from each division.

Winners only. No runner-up replacements. Players fully affiliated with more than one club may represent either club but not both.

Silver Division 36 Holes Stroke play. The Gross Winner to receive the Champion of Champions cup and prize. Other prizes gross runner up and net prizes according to entries received.

Bronze 1 Division 36 Holes Stroke play. The Gross Winner to receive the championship cup and prize. Other prizes gross runner up and net prizes according to entries received.

Bronze 2 Division 18 Holes Stroke play. The Gross Winner to receive the Championship Shield and Prize. Other prizes gross runner up and net prizes according to entries received.

Ties. In the event of a tie in any division there will be a sudden death play-off on such holes that the committee decide.

Carts. In line with TGA Policy, carts may be used for the 36 Hole Champion of Champions. It is the players' responsibility to make arrangements with the host club or privately. No Medical Certificates will be required

GROSS STABLEFORD ROSEBOWL

Competition will be 18 holes Gross Stableford.

Club Team. Only one team per club is eligible comprised of three members – the Silver and Bronze champions and the Bronze runner up **OR** if a club has only an open championship, the leading Silver player and the two leading Bronze players.

Substitutes. Silver and Bronze **stroke play** champions may be replaced by the next available player who finished closest to the winner in her division.

Silver and Bronze **Match play** champions may be replaced by the runner up. The Bronze runner up may be replaced by a semi-finalist. Open match **OR** stroke play. Either the next available player who finished closest to the winner in her division. THERE IS ONLY ONE SUBSTITUTE OPTION FOR A PRESCRIBED MEMBER WHO IS UNAVAILABLE. See NZG Club Manual for amplification.

Carts. Carts may be used by players in the Rose bowl team. It is the players' responsibility to make arrangements with the host club or privately. No medical certificates will be required

RULES for both 18- and 9-hole players

1. Open to all Clubs affiliated to the Taranaki Golf Association.
2. They are to be played on net differential.
3. Any player with a maximum handicap of 54 can put in a Home Pennant score.
4. There will be seven competitions. They are to be played during the last full week unless it falls on a public holiday in the months of March, April, May June, July, August and September, commencing on Monday and finishing the following Sunday.
5. Copies only of the four best net cards from each competition must be sent to recorder of the Home Pennant Results.
6. The three best cards will count in each competition. The fourth card will only be used as a count back card in the event of a tie.
7. Only four competitions need to be played. In the event of a club playing in more than four competitions, the best four of those played will count.
8. The association will award a Rose Bowl to be held for one year by the winners of the 18-hole competition and a silver vase for the runners up. A trophy will be awarded to the 9-hole winners
9. Monthly results are to be sent within two weeks of each competition to the recorder of the Home Pennant Competition.
10. The recorder is to be a member of the Taranaki Golf Women's Events
11. Full playing members of more than one club are eligible to compete. Cards will be accepted from each club.
12. 9 Hole competition to be played at the same time as the 18-hole competition.

RULES FOR TAPLIN CUP

Taplin Cup Recorder:

Sue Goble: – 021 366 336

1. A challenge for the cup shall be open to any club affiliated to the Taranaki Golf Association.
2. Matches are to be played on the course of the club holding the cup, but once the club has had 3 challenges on their home course the 4th challenge must be taken on the road.
3. Teams will consist of five players using their handicap Index.
4. The competing teams to be matched evenly. Players must be placed in order of handicap on the day of the match and matched as evenly as possible.
5. Handicap indexes of the challenging teams to be forwarded to the holders after the challenge has been accepted, seven days prior to the match.
6. Challenges must be in writing and accepted in the order that they are received.
7. The holders will suggest two dates for the match within three weeks of receipt of the challenge. If the dates offered are not suitable to the challenger, the challenge lapses. The holders continue to nominate challenge dates when playing on the course of the challengers. All challenges should be played as soon as reasonably possible.
8. If the course is declared unplayable on the day, the two clubs shall negotiate another date within ten days or the challenge lapses.
9. The competition shall be decided by the number of games won or lost. Halved matches count as half. In the event of a draw the holders retain the trophy.
10. The holders have the right to refuse to play the same club more than twice in a season.
11. If a player is a member of more than one club she must nominate which club she will represent for Taplin Cup Challenges in any one season.
12. The secretary of the club holding the cup shall forward the results to the recorder as soon as possible after the match, giving names, handicaps and results of each match. The recorder shall be a member of the Taranaki Women's Golf Committee.
13. In the event of a club losing the cup, challenges that have been accepted but not played are automatically transferred to the new holders, taking priority over further challengers.
14. The host club appoints a disputes committee of three, preferably the Club Captain, Secretary and one other.
15. Matches to be played throughout the golfing year.

Taranaki Golf Women's Golfer of the Year

The Edna Little Silver Tray

Conditions:

1. This is an annual competition open to all 18-hole players who have a Golf NZ handicap and are members of any affiliated club in the Taranaki District Golf Association.
2. The competition takes effect from **18th January to 31st October** each year.
3. Eligible open tournaments must be ***within*** the Taranaki Region and hosted by a club or organisation affiliated to Taranaki Golf. This can include foursomes (only for a participation point) and mid monthly tournaments. Pennant games do not count.
4. Each player is responsible for keeping her own records, (suggested form next page) which need to be certified by an official at each event or by your club captain or secretary. Entries must be received by the TWG secretary no later than 7th November each year.
5. The trophy, 'The Edna Little Silver Tray' will be presented at the Champion of Champions each year.
6. The award will be decided on the greatest number of points scored according to the following requirements.
 - **1 point** for participation (refer condition 3 above)
 - **2 points** for winning any section (Gross, Nett or Stableford) (refer condition 3 above)
 - **1 point** for runner up in any section Gross, Nett or Stableford) (refer condition 3 above)
 - **2 points** section winner in any match play tournaments (refer condition 3 above)
 - **1 point** section runner up in any match pay tournaments (refer condition 3 above)
NOTE: Flight winners or runners up, Elimination and /or Consolation winners are **not** eligible for points
 - **2 points** Club Championship – all divisions – winner
 - **1 point Club** Championship – all divisions – runner up
 - **1 point** for each stroke reduced in handicap over the qualifying period.

i.e. player has 24.5 handicap on 18th January and is on a 22.5 on 31st October A 2 whole point reduction = 2 points

The TG Women's Events will determine a format to use in the event of a tie.

Clarification of a 'sudden death playoff'

- In the event of a 'tie' the Committee shall decide on the hole(s) to be played until a winner is found.
- These shall be consecutive holes
- Committee members or Conveners should attend and act as referees if required
- A player achieving a hole in two during a sudden death play-off will be awarded a ball or cash depending on the format being played.
- Handicaps remain in play

Formats for different competitions have processes determined in the Women's Events Yearbook (excerpts below)

Champion of Champions

In the event of a tie in any division there will be a sudden death play-off on such holes the committee decide.

27 Hole Foursomes

In the event of a tie for the **gross** winner there will be a sudden "sudden death" play off over such holes as decided by the committee. Nett prizes will be decided from the Dot Golf results report. If a Dot Golf report is not available, conduct a manual count back.

36 Hole Strokeplay

In the event of a tie in the Silver Division or the Bronze Division there shall be a "sudden death" playoff on such holes as the Committee decide.

Taranaki Teams Tournament

The total of the best three cards is used for scoring. In the event of a 'tie', the score of the 4th team member is used.

Taranaki Teams and Over 50's Tournament

In the event of a 'tie' a winner and subsequent place getters shall be determined by the Dot Golf results report

Mid-Week and Weekend 18 Hole Pennants

In the event of the competition being tied at the end of round robin, then the winner will be decided by a sudden death play-off between the No 1 players from each team. Holes to be played as set down by the committee at the time. Handicaps still apply in a play-off.

If necessary, subsequent 2nd, 3rd & 4th positions will be determined by a countback on matches won through the competition.

9 Hole Pennants

In the event of a tie at end of season there shall be a count back on holes won and lost. If still a tie there will be sudden death playoff between the No 1 players over such holes as decided by the convener.

Guidelines and General rules Governing all Women's Events 18 Hole Pennant Competitions.

1. All competitions shall be played in accordance with the association rules governing the competition, the rules of golf and the host club's local rules. Normal Match play strokes and rules apply.
2. Any Club affiliated to Taranaki Golf may compete in the Pennant competitions.
3. Players must be of amateur status and be financial members of a club within the Taranaki District.
4. Each Club entering a team must be prepared to offer their course as a venue.
5. Mid-Week and Weekend teams consist of 5 players within the handicap index range of 0-54.
6. Composite teams may be entered with the consent of the Association. No player who has played for one club in any pennant match in the competition can subsequently during the same year in the same competition play for another club. Midweek and weekend are two separate events.
7. The Team Captain must give the team names and index handicaps to the host club representative, in correct handicap order. If players in a team have an identical index, the Team Captain must refer to the Club handicap order to find the correct order of players. (found in Golf NZ).
8. Matches are to be played in 4's off 2 tees or as directed by the convener. No 1's together followed by No 2's and so on.
9. Matches will be played over 18 Holes but may finish when a match is won. The overall club competition points awarded will be two (2) points for a team win and one (1) point for a half. (In the case of a tie - Individual games will only be taken into account should a count back be necessary at the completion of all matches played over the season.)
10. Late arrivals are disqualified under rule 5.3a, but the match committee of the day may apply exception 3. When a team cannot be fielded or defaults, they will lose two (2) competition points. If this occurs on the final day the deduction points will carry over to the following year.
11. Number of Players - Please note this is a team event and therefore a team of less numbers can still play. Can be as few as three players.
12. Any club defaulting or fielding less than 5 players must advise the Convener and the club they were meant to be playing against, before match day. The team fielding less numbers will all move up in playing order.
13. Pennant Conveners of the Women's Events are responsible for arranging matches and keeping a record of results.
14. 18 Hole pennant games will commence at 9.30am.
15. Every player must return her score card. Enter your score as per guideline sheet for non-played holes.
16. Should play not take place on the scheduled day, an alternative day will be set for both Midweek and Weekend Pennant.
17. In the event of the competition being tied at the completion of all rounds then the winner will be decided by a count back of holes won throughout the current competition season then if still tied, there will be sudden death play-off between the No 1 players from each team. The holes to be played are set down by the committee at the time. Please note handicaps still apply in a play-off. if there is a tie for 2nd or 3rd this will be decided by a count back on matches won throughout the whole current season.
18. A 9-hole member from a Club can NOT play 18 Hole Pennant.
Currently this is a 10 team, 9 Round competition, with the last round being considered the "Final" round. Any players who have not played Pennant that season before the last "Final" round are not permitted to play in it.

HOST CLUB RESPONSIBILITIES FOR PENNANT DAYS

1. Supervise start times and see to the smooth running of the day.
2. Collect the team sheets from team captains and set up a results board.
3. Ensure that a match and disputes committee of three (3), which includes the pennant convener (or in her absence a member of the TG Women's Events) is available to settle disputes in consultation with the team captains involved. Unresolved disputes to be referred to Taranaki Golf Women's Events.
4. Clubs may organize a two's competition (self-liquidating) and run a raffle for their own club.
5. Arrange catering for the day.
6. Display the local rules.
7. Should a course be closed or considered unfit for play by the Green Superintendent, the Club Captain or her representative, the pennant convener and pennant contacts must be notified in time to contact distant clubs. It is the host club's responsibility to decide if play is possible.
8. If weather conditions deteriorate during play, the convener's discretion shall apply.

Scores to enter where less than 18 holes are played

For an 18-hole round you need to play a minimum of 10 holes. The remaining holes will be scaled up as shown on the table below:

For a 9 hole round all 9 holes must be played to be eligible for handicapping.
